

**Applebee's Date Night Pass™ Promotion
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Applebee's Date Night Pass™ Promotion (the "Promotion" or "Sweepstakes") starts on February 4, 2025, at 8:00 a.m. Eastern Time ("ET") and ends on February 12, 2025 at 11:59 p.m. ET ("Promotion Entry Period"). Entries not received within the Promotion Entry Period will be void.

ELIGIBILITY: Promotion is open to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older and Club Applebee's® members. Club Applebee's® is free to join and maintain membership, which can be accessed at www.applebees.com. Employees of Applebee's Services, Inc. WINNER NOTIFICATION: Sponsor's decisions are final and binding on all matters relating to this Promotion.
